

"The treasurer shall have charge of all dues and other monies paid the Club and shall deposit same in the name of the Club. The treasurer shall pay all bills, obtaining a receipt for same. The treasurer shall give a financial report at each monthly meeting, giving an account of all monies received and spent during the last month. The treasurer shall solicit a substitute to act in his behalf in the event he is unable to attend any meeting of the club where a financial report is appropriate. There shall be a member of the Club (an "alternative treasurer") in addition to the treasurer who shall have signature authority for all Club accounts in any accredited financial institution. This "alternative treasurer" shall have the capability to conduct the financial affairs of the club for a period of at least one month in the event the elected treasurer cannot fulfill the assigned duties. Fort Wayne Radio Club Minutes 16 September 2005

The September 2005 meeting of the Fort Wayne Radio Club was held at the Good Shepherd United Methodist Church on 16 September 2005 with President Tom Baker as the host. There were about 20 persons present.

OLD BUSINESS:

The July meeting minutes were read and there were no corrections.

Treasurer Bob Streeter gave the Treasurer's report. As of 16 September, 2005 the FWRC had realized an income of \$3,679.58 and expenses of \$4,550.79 for the year. This represents a deficit of some \$871.21 for the year to date, the majority of it the result of expenses associated with the repeater move. Cash on hand was \$126.00 and we had a total of \$5,371.93 in Checking/Savings. So far we have about broken even on the chicken sale.

NEW BUSINESS:

Tom Baker noted that the club would provide communications support for the Heart Association Walk-a-Thon Saturday, 17 September at IPFW. The Walk-a-Thon will occur between 09:00 and 10:30 and will consist of one and three mile loops for the participants. Tom stated that he needed about 12 volunteers total.

Tom stated that in addition to the election of club officers during the upcoming elections in October, we will also have the position of club trustee on the ballot. Our current trustee Lynn Hyndman has served as trustee for about the last 25 years and is now spending about half the year in Florida. Hence he has asked to retire from the position.

Tom also noted that there would be proposed changes to the Constitution and By-Laws on the ballot. Tom described the proposed changes and passed a copy of the proposed revised documents out at the meeting. The proposed changes will again be described at the October meeting prior to the vote.



Amateur Radio Antenna "CC&R Bill" Reintroduced In Congress



from *The ARRL Letter* – New York Congressman Steve Israel has reintroduced legislation that could make it easier for radio amateurs living in communities with deed covenants, conditions and restrictions (CC&Rs) to erect suitable antennas. Arkansas Congressman Mike Ross, WD5DVR, signed aboard as an original cosponsor of the "Amateur Radio Emergency Communications Consistency Act" (HR 3876). ARRL Hudson Division Director Frank Fallon,

N2FF, attended Israel's public announcement of the bill September 19 on Long Island.

"Unfortunately if all new housing developments contain deed restrictions forbidding outside antennas there will probably come a time when there will not be enough ham radio operators to help their neighbors and countrymen," said Fallon. He believes Israel's bill will help to ensure that Amateur Radio will continue to be able to provide emergency communication should a disaster occur.

Fallon, who heads up the League's grassroots lobbying initiative, noted the bill's introduction comes in the immediate aftermath of positive media coverage of Amateur Radio's response to the Hurricane Katrina disaster. He was on hand for Israel's public announcement, which took place at the home of ARRL New York City-Long Island Emergency Coordinator Tom Carrubba, KA2D.

The one-sentence measure is identical to the text of the CC&R bill that has been introduced in the last two sessions of Congress: "For purposes of the Federal Communications Commission's regulation relating to station antenna structures in the Amateur Radio Service (47 CFR 97.15), any private land use rules applicable to such structures shall be treated as a state or local regulation and shall be subject to the same requirements and limitations as a state or local regulation." The measure would put private land-use regulations, such as homeowners' association rules, on the same legal plane as state or local zoning regulations under the FCC's PRB-1 limited federal preemption. PRB-1 now applies only to states and municipalities.

ARRL President Jim Haynie, W5JBP, this week encouraged League members to write their elected representative and ask that they cosponsor and support the bill, especially given two hurricane emergencies in short order.

"Amateur Radio is certainly a part of this nation's communications infrastructure," Haynie said. "What we're asking for is just a fair shake so we can put up antennas and help our fellow citizens." While the League has ramped up its efforts to educate members of Congress about Amateur Radio, Haynie said lawmakers respond best to individual members.

HR 3876 has been assigned to the House Energy and Commerce Committee. Information about the bill and a sample letter to use when contacting your representative are available on the ARRL Web site http://www.arrl.org/govrelations/hr3876/>.

In his formal announcement this week, Israel said that "often unsung" Amateur Radio volunteers were instrumental in helping residents in the hardest hit areas in the wake of Hurricane Katrina, including saving stranded flood victims in Louisiana and Mississippi.

"State and local governments, as well as disaster relief agencies, could not possibly afford to replace the services that radio amateurs dependably provide for free," said a statement from Israel's office. "However, the hundreds of thousands of Amateur Radio licensees face burdensome regulations that make it extremely difficult to provide their public services."

Amateur Radio Vanity Processing Falls Victim To Hurricanes

from *The ARRL Letter* – The FCC's Wireless Telecommunications Bureau (WTB) has suspended the processing of Amateur Radio vanity call sign applications. A WTB staff member, speaking to ARRL on background, said the FCC



halted vanity processing on or about September 23 after realizing that filing and regulatory deadline extensions for hurricane-affected licensees in certain states could adversely impact the vanity system. The WTB staffer pointed out that the filing extensions announced this month also apply to Amateur Radio's two-year "grace period."

"Because these extensions apply to the grace period, it could affect vanity processing," the WTB staffer told ARRL. "We stopped processing when it came clear that some call signs could be affected." No decision has been made on when vanity processing will resume.

Pennsylvania Utility Cites Unfavorable Economics In Ending BPL Trial



from *The ARRL Letter* – PPL Broadband announced this week that it's terminating its broadband over power line (BPL) experiment in Pennsylvania's Lehigh Valley. According to media reports, the company is citing the high cost of a full-scale BPL rollout and competition from cable and DSL

service in the region as the reasons for the shutdown. Approximately 300 households participating in the trial were said to be paying \$40 a month for the high-speed Internet service. Although Amateur Radio stations in some of PPL Broadband's service area reported BPL interference, the company did not cite it as a factor in its decision to drop out of the BPL race.

"Several local amateurs reported interference to their home stations," said ARRL Laboratory Manager Ed Hare, W1RFI, who visited the Lehigh Valley several times to take BPL system emission measurements. "While this was resolved in whole or in part by PPL, in one case the interference was 'fixed' by turning off BPL completely to the street in front of the amateur reporting the interference." Even so, Hare says, the amateur continued to experience moderate interference from other parts of the system.

PPL claimed it had no BPL equipment operating on the spectrum the complaint targeted. During a visit a few weeks later, however, Hare said he was able to quickly pinpoint the source "on the band PPL claimed it wasn't using" about a half mile away from the ham's location, although PPL was never able to completely resolve the case.

Hare reports the BPL system was creating S9 noise on entire ham bands within a "rather large" deployment area. "Had this system continued to build out, additional reports of interference from mobile and fixed amateur operation would have been inevitable," he predicted.

ARRL CEO David Sumner, K1ZZ, said he wasn't surprised to learn of PPL's decision to get out of BPL. "It bears out what knowledgeable economists have been saying about BPL's prospects for some time," he said. "PPL has considerable excess fiber capacity and was trying to leverage that investment by offering broadband service to consumers via BPL. If they couldn't make it pay, it's doubtful anyone else can."

The Allentown company first offered BPL Internet service in Whitehall Township and Emmaus, later expanding to parts of Bethlehem, Upper Macungie Township, Hanover Township and Northampton County. In its formal comments in the FCC BPL proceeding, the ARRL cited measurements taken at one site within the BPL test system in Emmaus that "exceeded FCC Part 15 limits by up to 20 dB or more."

An October 4 article in Allentown's The Morning Call newspaper quoted PPL spokesman Jim Santanasto as saying that the utility couldn't charge enough in the face of stiff cable and DSL competition and that its pool of potential customers was too small. "The economies of scale wouldn't work," the paper quoted Santanasto as saying.

On September 1, the FCC extended until October 31 all filing and regulatory deadlines falling between August 29 and October 30 for licensees in Mississippi, Alabama and Louisiana affected by Hurricane Katrina. On September 24, it extended until November 21 all filing and regulatory deadlines falling between September 20 and November 20 for licensees in Louisiana and Texas affected by Hurricane Rita.

The WTB staff member emphasized that the FCC intended the deadline extensions to apply only to licensees who have been directly impacted by the storms. "These are not statewide extensions," the staffer said.

Under Part 97, Amateur Radio licensees have two years from the date of license expiration to renew their tickets without having to retest or risk losing their call signs to a vanity applicant. The staffer confirmed that WTB had disabled the "auto-termination" feature of the Universal Licensing System (ULS) so that it will not automatically cancel licenses that have not been renewed by the end of the grace period.

"We can't assume based on address who might be affected," the staff member explained, "so we're not auto-terminating anything at this point."

In the meantime, the FCC is encouraging radio amateurs to continue filing vanity applications as they normally would. "Everything will be held in queue," the WTB staff member said.--thanks to Dean Gibson, AE7Q, for alerting ARRL to this situation



ARRL Announces 2005 Toy Drive For Hurricane Victims

from *The ARRL Letter* – In the wake of unprecedented hurricane devastation in the Gulf Coast region, the ARRL has announced it will again sponsor a toy drive to brighten the holidays for youngsters left homeless or displaced as a result of the storms. Country singer and ARRL member Patty Loveless,

KD4WUJ, has agreed to serve as honorary chairperson for the 2005 toy drive. ARRL President Jim Haynie, W5JBP, is urging the Amateur Radio community to pitch in.

"Last year, hams from all over the country brought smiles to children during the holidays," Haynie said. "We made a lot of friends, and we did a lot of good. No one expected that we would need to do it again so soon, but the recent hurricanes' destruction changed the plans of a lot of people."

Last year, individual radio amateurs and clubs across the US joined together to collect new toys for youngsters affected by a series of four hurricanes in Florida. ARRL Media and Public Relations Manager Allen Pitts, W1AGP, says the 2004 effort was a success beyond anyone's wildest dreams, and there was no question in his mind about doing another toy drive for the latest hurricane victims.

"Not only can it be done, it really must be done. It is simply the right thing to do," he said. "We are asking hams from all over the country to begin gathering new toys for shipment

to Memphis, Tennessee. ARRL Delta Division Vice Director Henry Leggette, WD4Q, has secured a receiving warehouse and is recruiting ham volunteers there."

Ham radio clubs and individual amateurs should send new, unwrapped toys for boys and girls aged 1 to 14 to ARRL Toy Drive, 1775 Moriah Woods Blvd--Suite 12, Memphis, TN 38117-7125. Plan mailings and shipments to arrive prior to Thanksgiving, Thursday, November 24, for distribution over the holidays.

"Just as we did last year, we are asking the donors to please put a QSL card into the box with the toy," Pitts added. Non-hams are encouraged to join this effort too.

"Early in December, we will divide the toys among the various agencies and states that need help the most at that point in time," Pitts explained. "We are making these arrangements so that we can maximize the areas receiving aid while maintaining the unique identity that this is the Amateur Radio Community's response."

Pitts says he's heard from many Amateur Radio clubs that are already gathering toys together. "Please check with your local club and see if they are planning a mass shipment," he urged. "If not, perhaps you can help organize one for your area."

Monetary donations to purchase new toys for special age groups and to help cover operational expenses also are welcome. Those wishing to donate money instead of toys can send a check to ARRL Toy Drive, ARRL, 225 Main St, Newington, CT 06111.
