The 37th Annual Fort Wayne Hamfest & Computer Expo, and Indiana State A.R.R.L. Convention, sponsored by the Allen County Amateur Radio Technical Society (AC-ARTS), will be held at the Allen County War Memorial Coliseum at the corner of Indiana 930 (Coliseum Blvd) and Parnell Ave. Open to the public 9:00 A.M. - 4:00 P.M. EST on Saturday and 9:00 A.M. - 3:00 P.M. EST on Sunday. Vendor setup is Friday evening and Saturday morning. Admission is only \$6.00 for both days or \$4.00 for just Sunday at the door only; Children 11 and under are free when accompanied by an adult. Parking is \$4.00. # Fort Wayne Radio Club Meeting Minutes, 16 October 2009

The October Meeting of the Fort Wayne Radio Club was held at the Good Shepherd United Methodist Church on 16 October 2009 with club president Tom Baker serving as host. There were about 35 persons present.

#### **Old Business:**

Tom Baker started the meeting with the pledge of allegiance and followed this by having all in attendance introduce themselves and their calls.

Al Burke read the September meeting minutes and there were no corrections.

Bob Streeter was absent, but data he provided to the Secretary indicated that as of 16 October 2009 the club had realized an income of \$1,935.99 year-to-date, expenses year-to-date of \$1,097.38, and had \$99.00 in cash plus \$7,479.22 in checking/savings. The repeater antenna replacement fund had collected \$453.06 in donations, plus a pledge of \$100.00 from Art Kidd, WK9DD. In addition, Jim & Annie Pliett and Carole & Al Burke had pledged a total of \$400.00 towards replacement of the 146.910 MHz antenna at Robison Park.

# **New Business:**

Joseph Lawrence, K9RFZ reported that Amateur Radio supported communications during the Simulated Emergency Test went well. Twenty nine people participated in the net and all events occurred in a timely manner. Joseph is preparing a report. He encouraged amateur participation in future SETs. He also noted that an Allen County ARES meeting would occur on 21 October in Room A of the (downtown) Allen County library wherein Joseph would be discussing the results of the SET.

Joseph also announced that a Technician's class course was to be conducted at IPFW the four Saturdays prior to the Ft. Wayne Hamfest with test-outs to be conducted at test sessions during the Hamfest.

Jim Boyer, KB9IH stated that he is looking for volunteers for the upcoming ACARTS Hamfest. If you are willing to help out with vendor check-in, security, call-in operations, PA announcing, and any number of other chores, please contact him.

Tom Baker noted that the FWRC would have two tables at the Hamfest, directly across the aisle from the

ACARTS control platform. The tables are available to all FWRC members who wish to sell stuff, provided that, persons desiring to use the tables for that purpose must agree to sign-up to man the club table for a block of time. The sign up sheet will be available at the table, or you may contact Tom Baker direct.

Larry Temenoff reported on a real-life foxhunting experience he had earlier this month. Seems that he received a phone call from the Federal Aviation Agency (FAA) requesting his support in locating the source of a signal emanating from the locale of IPFW's campus. The signal, on 120.450 MHz was interfering with aircraft trying to land at Detroit Metro airport. (120.450 MHz is one of Detroit-Metro's approach control frequencies). The FAA said that the interference occurred in the Fall and Spring time period and was emanating from or around the IPFW campus based upon measurements made using an FAA King-Air snooper aircraft The FAA sent a vehicular based direction finding system up from their Kansas City office and together with help from Larry and folks from Comcast, they found the source in a housing unit off Hobson Rd. It seems that the housing unit had an obsolete, but still powered TV antenna, pre-amp, distribution amplifier located in the attic of the housing unit The pre-amplifier had gone mustang and was oscillating on frequencies around 120.450 MHz depending upon the temperature. Shutting off the power to the pre-amp solved the problem and everyone went away (apparently) happy.

Tom Baker reported that the Board of Directors had voted to replace the Robison Park 146.910 MHz antenna with the intent of restoring the 146.910 MHz repeater to operation along with its Echo-Link capability. Tower climber and replacement antenna quotes are being pursued. The Board also voted to start a maintenance action on the club's trailer aimed at repairing the trailer running, brake and turn lights which are at present not functioning correctly. In addition, a cost estimate to replace the floor and side walls of the trailer (which are disintegrating) will be prepared.

Tom Baker reopened nominations for the club's officers and Board of Director positions for the 2010 club year. Jim Pliett, K9OMA was nominated and agreed to run for a Board position. After the nominations were closed it turned out that there were only one person each willing to run for the following positions:

That is all I have for this month. See you at the Hamfest.



# **W1AW Frequency Measuring Test**

from *The ARRL Letter* - The W1AW Frequency Measuring Test (FMT) has taken several different formats over the past few years. This year, we return to the "classic" FMT -- measur-



ing the frequency of an unmodulated carrier. Accurate frequency measurement is required of all hams for both regulatory compliance -- "stay in the band!" -- and operating convenience, particularly on the new digital modes. The W1AW FMT will run on November 12, 2009 at 0245 UTC (this is Wednesday evening, November 11, 2009 at 9:45 PM EST). It will replace any W1AW bulletin normally scheduled for that time. It is recommended that participants listen to W1AW's transmissions prior to the event to get an idea of conditions to see which band (or bands) will be best for measurement purposes.

The basic techniques for making carrier frequency measurements are the same as described back the October 2002 issue of QST. According to QST Contributing Editor H. Ward Silver, N0AX, you don't need a basement full of sophisticated lab equipment to make a surprisingly accurate measurement. "The frequency accuracy of most radios sold in the past decade is specified as  $\pm 10$  ppm or better," he explained. "By calibrating your radio to a known frequency reference such as WWV or CHU and letting it reach an even, stable temperature, your measurements can be within 1 ppm or even better." The 2006 FMT announcement includes a sidebar on calibrating your receiver to an over-the-air frequency reference.

# Format and Schedule

The FMT will begin with a general W1AW (QST) call beginning exactly at 0245 UTC sent simultaneously on two amateur frequencies. The test will consist of 20 second key-down transmissions, followed by a series of Vs, followed by station identification. W1AW will identify before, during and after the transmissions. The test will last for a period of approximately 5 minutes total. The approximate frequencies for the carriers will be as follows: 80 meters near 3597 kHz and 40 meters near 7097 kHz.

Thanks to volunteer Mike Fahmie, WA6ZTY, a 40 meter-only West Coast run will follow the W1AW transmissions by 15 minutes, beginning at 0300 UTC and will follow the same format as W1AW. The approximate frequency will be 7096 kHz.

Our multi-op effort last year in the CQ World Wide Phone Contest (you can read about it in the November 2008 Allen County HamNews) pretty much went off without a hitch.

So we expected the same to happen in our repeat effort this year. But Murphy had other ideas, and he paid me a personal visit prior to the contest.

You've probably read about Murphy and his First Law - if anything can go wrong, it will. There are many corollaries to this - for example, if anything is going to fail, it will be the most critical item (kind of makes sense). So what happened prior to the K9LA multi-op effort this year?

One of the improvements from last year was to replace the second-station inverted-vees on the tilt-over tower with a second 20m/15m/10m Yagi on a new crank-up tower. The Yagi part went good, and it is sitting on the garage roof waiting to go up. The problem was the new crank-up tower. Bob NY6J and I spent much time assembling the crank-up tower, banging on it, disassembling it, and then again re-assembling it. About a week before CQ WW PH it was obvious that the new tower was not going to be ready, so we reverted to Plan B-just put up the inverted-vees for 40m, 20m, and 15m like last year. I conceded this effort to Murphy, so it was Murphy 1, K9LA 0.

The next problem happened about two weeks before the contest. My main amp, a Commander HF-1250, quit working. After some brief troubleshooting efforts, I isolated the problem to the solid state relay in the 220 V primary that prevents in-rush current. A quick call to Allied Electronics got a replacement part on the way. It was installed on the Sunday before CQ WW PH, and the amp was again working. Now the score was even - Murphy 1, K9LA 1.

The tie breaker in the Murphy versus K9LA competition was my personal schedule and my work schedule. Two weekends before CQ WW PH found me (and my wife Vicky AE9YL) at the RSGB Convention (near London) performing DXCC card checking duties. We had a great time (a future column), but I lost a full weekend (and several weekday evenings) that could have been devoted to the crank-up tower problem. To top that off, I went on travel for work after our U.K. visit. This work trip included a visit to our Fullerton (California) facility on the Friday a week before the contest - which meant I lost the Saturday before the contest traveling back from the West Coast. Thus the final score was Murphy 2, K9LA 1.

Regardless of everything that happened, a bunch of us did do the contest (including several new to DX contesting), and we had fun. So in a way we did beat Murphy. But he definitely won in the "try to improve the station capabilities compared to last year" category.

When I look back on this, the critical decision was me telling the adaptor plate vendor that I didn't need the plate until late September (the adaptor plate allows the bottom section of the new crank-up tower to mate to the existing forks in the cement from the old tilt-over tower). I assumed everything was going to go off without a hitch, but it didn't. Hmmm, this sounds like another one of Murphy's corollaries - if you assume the best will happen, it won't.

After a vote by secret ballot, and after counting the votes thus cast, the three Board positions for the 2010 club year will be filled by:



Connie Marshall, K5CM, in Oklahoma will make additional transmissions on 160 and 80 meters following the transmissions of West Coast station WA6ZTY, at approximately 0315 UTC. The approximate frequencies for the carriers will be as follows: 160 meters near 1845 kHz and 80 meters near 3578 kHz. According to W1AW Station Manager Joe Carcia, NJ1Q, K5CM's central location should provide a much stronger signal in mid-continental areas.

All transmissions -- no matter which station they originate from -- will consist of a call-up/QST transmission lasting for approximately 3 minutes, followed by three 20-second key-down periods of unmodulated carrier.

# Reporting and Results

Your report should be submitted via the FMT Report form on the FMT Reporting and FMT Results Web site no later than 2359 UTC on November 15. Along with your call sign and e-mail address, enter your most accurate frequency measurements on each band and indicate whether you measured the W1AW, WA6ZTY or K5CM's signal. There will be a window to list your equipment, describe the method you used to make the measurements and enter any Soapbox comments. After the entry page has been closed, the Web site will then automatically calculate the measurement error of each report and display the actual transmission frequencies. The information entered by each reporting station will also be displayed as in previous FMTs. (The results for recent FMTs are on the W1AW FMT page.)

# The Foxhunt Chronicals October 2009 - Al Burke, WB9SSE

The 9th Fox hunt of the 2009 season was held on Sunday afternoon, the 4th of October. The temperature was in the mid 60's and the sky slightly overcast, perfect weather for a hunt.

The October hunters consisted of five teams including Jim & Kim Machamer, KB9's DOT & DOS plus Brian & Debra Jenks, W9BGJ & KB9ZQG, the team of Jim Pliett & Al Burke, K9OMA & WB9SSE, the team of Steve Nardin and Larry Temenoff, W9SAN & KB9OS, and Charlie Ward, KC9MUT and also Woody Woodbury, KC9CGN.

On this hunt Carl Thomas, WB9YBI and his daughter Jessica, KC9PUY served as the fox. They implanted the fox smack at the midpoint of the "Willis Family" pedestrian bridge that crosses Crescent Ave just north of Coliseum and allows IPFW students to travel between the IPFW campus and the student housing complex on the east edge of the IPFW property. The fox radiated about 20 watts. Carl and Jessica watched and controlled the fox from the roof of the IPFW parking garage on IPFW's campus, perhaps a distance of 1/4 mile from the fox. Given that Carl's rig was sitting there in the middle of the bridge, he had a little concern that a passing-by dude would say "Wow, what's this here?", and then start running with a "new toy". Hence he cleverly set the audio on the fox so that the input could be heard from the radio on the bridge. Thus every time he noticed a passing pedestrian looking at the fox, he would simply transmit "Tick, tick, tick".

All hunters heard the initial fox transmission easily from their starting point at the Off-Track Betting Parlor parking lot at Lima Rd. and Washington Center Rd. Initial bearings indicated "North-East", so off we went thinking" Either Leo or New Haven...again". Further bearings and the signal strength suggested (to Jim & I) that the fox was located somewhere in the Paper Mill Bluffs subdivision, so we wandered around in that complex for about 15 minutes before we decided that the fox had to be on the other side of the St. Joe river. When we got on the other side of the river, the readings convinced us that the fox had to be somewhere on the IPFW campus. And knowing how sneaky Carl is, we guessed that he might be located in the campus parking lot. But when we got on campus, the DF readings suggested that the fox was located on the east side of Crescent Ave. When we crossed Crescent and took bearings from the student housing complex, the readings pointed back towards the campus. At this point we were both very dejected thinking that some or all of the other teams had already found the fox. However, given the DF readings we had taken. Jim suggested that the fox just about had to be ON the Willis Bridge. And then he noticed an antenna at the midpoint of the structure. So he took off on foot and located the little devil smack in the mid-point of the bridge. Much to our (later) surprise it turned out that we were the first to find the thing.

I had noticed from Carl's taunting fox transmissions a bit of wind noise, hence I figured that Carl had to be on the roof of the parking garage. So Jim and I drove over to the garage and observed all of the other hunters, highly frustrated, and wandering around the base of the garage. We went up to the roof and found Carl and Jessica with diabolical grins on their faces, and also discovered that we had found the thing first. I think the periodic metallic stricture of the Willis Bridge, and perhaps the re-bar in the structure of the parking garage caused DF readings in the vicinity of the parking garage to be totally unreliable.
