
and Al made sure it got done. The entire club can not thank you enough.

Fort Wayne Radio Club Minutes November 11, 2005

The November 2005 meeting of the Fort Wayne Radio Club was held at the Good Shepherd United Methodist Church on 11 November 2005 with President Tom Baker as the host. There were about 20 persons present.

OLD BUSINESS:

The October meeting minutes were read and there were no corrections.

There was no Treasurer's report.

NEW BUSINESS:

Tom Baker announced that we would be holding an open house at the new repeater site Saturday, 12 November from 09:00 till noon. All are welcome to attend.

Tom noted that the Board of Directors had voted to raise the fee for a mailed copy of the Ham News from the present \$6.00 per year surcharge to a \$12.00 per year surcharge. This will cover the actual expense of printing and mailing a hardcopy of the Hamnews. The change will take effect concurrent with the CY 2006 dues.

Al Burke reported on the November Foxhunt. Jim and Annie Pliett and Al and Carole Burke were the fox. For this hunt Carole fabricated a black flag with a pocket in it that contained the fox. The flag was raised beneath the US flag at the front entrance to Carroll High School, and the flag contained the legend "El Zorro" (Spanish for "The Fox"). In addition to the diverse vendors, the great flea market, the nice prizes, and the interesting forums, this year's Ft Wayne hamfest again offered two activities for DXers and other award chasers: DXCC, VUCC, and WAS card checking, and a DX dinner.

Card checking included DXCC applications by Scott N9AG, Mike N9NS, and Carl K9LA. VUCC and WAS card checking was handled by Vicky AE9YL. The DXCC card checkers handled thirteen applications totaling about 900 QSOs. AE9YL handled three VUCC applications and one WAS application.

The DX dinner (that name is quite loose for this function - in reality it included more than just DXers) took place Saturday evening at the Red River Steakhouse in the Ft Wayne Marriott (Coldwater and I-69). This was the second annual DX dinner - the first one was held last year at the Tumbleweed restaurant on Lima Rd (now closed), and was attended by about 12 people. The festivities for this year's event started at 5 PM, with

some participants showing up a bit earlier to partake of some adult beverages in the bar.

award to Jim Edwards, KA9DIF.

Jim has been active in amateur radio for over two decades. He continues to lend his expertise as a volunteer examiner to the Wabash Valley Amateur Radio Association.

Jim is the director of the Ryves Hall Youth Center, a facility for underprivileged children, here in Terre Haute. Since becoming director in 1982, Jim has been a positive role model to countless children in the Terre Haute area. Amateur Radio is an important part of the his life and that of his family. Three members of his family are licensed as well.
