ARRL Indiana Section Manager Lou Everett, WA5LOU, provided information August 28 regarding communications related to Hurricane Isaac.

The Delta Division Emergency Net is running on 7.275 MHz during the day and 3.890 MHz at night.

The Louisiana Traffic Net will run from 1700Z Aug. 29 to 2300Z on 7.243 MHz and move to 3.910 MHz at 2300Z.

Lou indicated that he has communicated with the Louisiana section manager. He told him that Indiana stands ready to assist in communication, if necessary.





The Delta Division Management Emergency Team has requested that hams not check in or interfere with these nets once they are activated, unless it is for official business and by invitation. "So, unless you hear otherwise, from me, please listen only," Lou wrote.

Lou said that if Indiana needs to activate its NTS nets for this event, he will make an official announcement. "Being ready is a good thing," Lou wrote. "Not having to be involved is even better, because that tells us they have things well under control, and our injection would only muddy the water. So, listen mode only, please!"

Hurricane Isaac emergency nets have now stood down.

GET IN ON THE VHF FUN IN THE 2012 ARRL SEPTEMBER VHF QSO PARTY

September is here — and according to ARRL Contest Branch Manager Sean Kutzko, KX9X, the VHF+ bands have been getting a workout: "If you've never experienced the fun of VHF+ operating, the 2012 ARRL September VHF QSO Party the weekend of September 8-10 is a great place to start. With many HF radios now offering at least 6 meter SSB/CW capabilities — and some offering 2 meters and 70 cm as well — any amateur with a Technician class license or higher can experience long-haul communication on the VHF bands."

Kutzko explained that September as opposed to June with its sporadic-E openings -- is known for good tropospheric propagation. "In the past week, there have been some good tropo openings in the mornings on 2 meters along the Eastern seaboard and in the Midwest. There's even been a touch of sporadic-E propagation on 6 meters this week, primarily in the western half of the US. Couple the recent openings with talk among the VHF Hopeful of some F2 propagation on 6 meters (due to the upswing of Solar Cycle 24), and the potential for enhanced propagation during the contest looks favorable."

While there will be some contest activ-

ity on FM simplex -- especially near large population centers -- Kutzko said that most long-distance VHF+ QSOs are conducted on CW or SSB, which means you need to use horizontally polarized antennas: "A dipole for 6 meters is only 9 feet, 4 inches long, and is an easy construction project," he explained. "Try to get the dipole in the air as high as possible, but even 15 feet off the ground will make some QSOs. If you have an antenna tuner that can handle 6 meters, you can try loading up another of your antennas on 6 meters with reasonable success. For 2 meters and 70 cm, a horizontal loop will work nicely for SSB and CW contacts." But remember: SSB and CW QSOs use horizontally-polarized antennas, while FM uses vertical polarization. You can find plans for simple VHF antennas at the Technical Information Service area of the ARRL Web site, in the Antennas chapter of The ARRL Handbook, or in the VHF and UHF Antenna Systems chapter of The ARRL Antenna Book.

Because VHF+ antennas are relatively small, Kutzko said that many amateurs operate from portable locations, such as a hilltop or a campground. "Find some high ground and put up an antenna; you'll be amazed at the difference operating from a high-terrain locale will make," he said.

"Others operate the contest as a 'rover,' operating from their car or truck while transmitting from multiple grid squares over the contest period. Tracking rovers during the contest is almost as much fun as the contest itself."

Activity will be centered on 50.125, 144.200, 222.100 and 432.100 MHz. These are the calling frequencies; it's bad etiquette to monopolize them. But Kutzko said that most SSB activity will take place between 50.125-50.250 MHz, and CW between 50.100-50.080 MHz. If conditions are exceptional, you may even hear signals above 50.250. But Kutzko advised that the frequencies between 50.100-50.125 MHz are a "DX Window," meaning it is reserved for QSOs between W/VE and DX stations, so please do not make state-side-to-stateside QSOs in that range.

The 2012 ARRL September VHF QSO Party runs from 1800 UTC Saturday, September 8 through 0300 UTC Monday, September 10. Complete rules and entry forms may be found here. All logs must be e-mailed or postmarked no later than 0300 UTC on Wednesday, October 10, 2012. While electronic logs are preferred, paper logs can be sent to September VHF Contest, ARRL, 225 Main Street, Newington, CT 06111.

HAMS TO PUT NINE AZOREAN ISLANDS ON THE AIR IN ONE WEEKEND

From ARRL News:

Stretching over a distance of 305 miles from east to west, the nine populated islands of the Azores count for a single DXCC entity and three IOTA groupings. A group of radio amateurs from eight countries and the

Azores will be putting these islands on the air September 28-30 for the Azores 9 Islands Hunt, offering an opportunity for the world to contact these nine islands during one single weekend.

Throughout the world Amateur Radio has played an important role in providing communications during disasters and emergencies for more than 100 years. The team gathering in the Azores for the Azores 9 Islands Hunt will also be promot-



ing the role of Amateur Radio disaster communications. While the Azores enjoy year-round nice weather, the islands are not immune to natural disasters. The Azores are situated on three of the largest tectonic plates, making the islands susceptible to powerful earthquakes. In recent years, heavy rains have created mudslides severely impacting the infrastructure and resulting in evacuations.

This 24-hour operating event is sched-

uled for Saturday, September 29 at 1200 UTC to September 30 at 1200 UTC. According to organizers, the stations will be active starting Friday, September 28 as soon as they become operational. The stations plan to be operating 40, 20 and 17 meters on CW and SSB as

follows:

CW: 7.000-7.015 MHz; 18.080-18.090 MHz; 14.050-14.065 MHz

SSB: 7.175-7.195 MHz; 18.120-18.135 MHz; 14.250-14.275 MHz

The following islands and stations will be on the air:

A VISIT TO WASHINGTON ISLAND

In the August Allen County HamNews, Ron WB9AA told of his June trip to W9EVT's Greengate Farms in Wisconsin. Coincidentally Josh W9HT visited W9EVT earlier in May. Here is Josh's story to W9EVT's QTH.

Perhaps you saw the QST article earlier this year about George Ulm, W9EVT, and his station which is located on Washington Island, Wisconsin. George is part of a generation of operators that is becoming scarcer with each passing year since he has been a licensed amateur radio operator since 1938. After reading about how George and his wife Susan have a bed and breakfast located on their farm (Greengate Farm) on Washington Island, I immediately realized that I should make a visit to Washington Island.

Located at the end of a long peninsula in northern Lake Michigan, Washington Island boasts a small population of approximately 700 people and is accessible through a 30 minute ferry ride. Although it is a popular travel destination in the summer months, the Island does not have any fast food restaurants. (If you go, try out some of the local restaurants. The fish is excellent.) The Island does have its own post office and grocery store which seemed to be closed on Sunday.

Greengate Farm is located on the premises of a 300 acre apple and cherry farm which is no longer in cultivation. The Farm

has numerous hiking trails and over a mile of shoreline, permitting a panoramic view of northern Lake Michigan. This year a pair of bald eagles has also made their home at the Farm. Greengate Farm features cabins with a comfortable range of modern amenities. The sky at night is very impressive due to the lack of city lights.

The Northern Lights are also a possible nighttime attraction if solar activity permits.

On Mother's Day weekend I made the drive up to Washington Island; this particular weekend was before the summer rush on Washington Island. The overall drive from Fort Wayne

through Chicago and Milwaukee was about 10 hours long.

George and Susan's hospitality was readily apparent. Three things about the trip to Washington Island stand out in my mind: the lovely setting at Greengate Farm, George's incredible stories, and operating as W9HT/P for the weekend.

After spending several hours conversing with George and touring his extensive

station, I was given the opportunity to spend as much time as I liked operating as W9HT/P from George's station. Since my home station only uses modest antennas and 100W at most, a rotating, directional antenna with a kilowatt of power from a remote location without any trace of local interference was a real treat. I usually operated after dinner until the early hours of the morning.

Over the course of the rest of the weekend, I made a wide range of contacts with stations across North America and a good number of DX stations. A glance at the first few entries in my logbook from the weekend tells the story: 7O, 6O, CN, HC, and 4X. Being able to work a few new DXCC entities on the first call was a real treat, too.

If you are looking for a fascinating place to visit, I cannot recommend Greengate Farm highly enough. The location is beautiful; the hospitality that you will receive is second to none, as are George's stories!

THE FOXHUNT CHRONICLES FOR AUGUST 2012

The Seventh foxhunt of the 2012 season occurred on Sunday, the fifth of August. The August hunters included Steve Irving, KC9AUQ, the team of Steve and Linda Nardin, W9SAN and W9LAN, the team of Kim & Jim Machamer, KB9's DOS and DOT, the team of Brian and Debbie Jenks, W9BGJ and KB9ZQG, the team of Charles Ward and Fred Gengnagel, KC-9MUT and KC9EZP, the team of Mark Berke, WA7NXI and his son Nathan, the team





consisting of Jim and Annie Pliett, K9OMA and KA9YYI plus Carole and Al Burke, WB9RUS and WB9SSE. In total, fifteen hunters were aligned for this contest.

Bob Dean and Dave Spence, KC9UHU and KB9VTK played the role of the wily fox. They hid out on the banks of the river behind the Old Fort complex, under a shade tree, and used a mobile rig and cubiclequad to initially taunt the hunters who were situated at the Off-Track Betting Parlor parking lot up on Lima and Washington Center roads. The actual fox was a micro-fox device ensconced in the trunk of a tree. This system was purpose-made for foxhunting and automatically produced a 60 second cw signal every five minutes with an output (I would guess) of around 10 milliwatts or so. (Dave Spence plans to measure the units fundamental and third harmonic output power levels when he gets it into the lab). In hunting for the fox after it was localized we noticed that the third harmonic was very weak, so much so that you had to be within a meter or so of it to pick it up, so there is a lot of interest in the measurements that Dave will be making.

Everyone heard the initial fox transmissions while sitting in the Off-Track Parlor parking lot and started heading south. The Ward / Gengnagel team took some very accurate bearings and essentially drove right to the Old Fort, having to travel only 4.3 miles, and they found the fox in just forty five minutes. They were followed by the Nardin and the Pliett /Burke teams, Steve Irving, Mark and Nathan Berke, and then Jim and Kim Machamer and Brian and Debbie Jenks.

Points garnered by the participants based upon our time-distance scoring criterion turned out as follows:

Consequently for the September hunt the duties of the fox will be provided by Charles Ward and Fred Gengnagel.
