# TIME TO WRITE YOUR CONGRESSMAN

#### ARRL SEEKS SUPPORT FOR "AMATEUR RADIO PARITY ACT OF 2014"

n June, 2014 with Congressman Adam Kinzinger (IL-16) as the sponsor and Congressman Joe Courtney (CT-2) as cosponsor, HR 4969 - the "Amateur Radio Parity Act of 2014" - was introduced into the 113th Congress. This bipartisan effort would direct the FCC to extend the "reasonable accommodation" provisions for amateur radio antennas to include all types of land-use regulation, including deed restrictions and restrictive covenants.

If enacted, HR 4969 would direct the FCC to extend the the reasonable accommodation protections to those amateurs who are living in deed-restricted communities. Known as "CC&Rs" (covenants, conditions and restrictions), these are the prohibitions and limitations placed on properties by builders or home-owner associations (HOAs) which prevent licensed amateur radio operators from erecting even modest antennas.

The ARRL is asking all members to contact their members of the US House of Representatives to state their support for HR 4969 and to ask their representatives to sign on as co-sponsors of the bill.

The ARRL asks that letters be mailed to ARRL for delivery instead of simply mailing them directly to the Congressional offices, for two reasons: First, since the 9/11 attacks and subsequent security threats, all incoming mail to Congressional offices is first diverted to a holding area outside of Washington DC. Once at that facility, it undergoes a series of scans to test for a variety of problems. Only after it passes the security tests is it forwarded on to Capitol Hill for delivery. The delay in delivery is generally in the five- to sevenweek range. The ARRL will hand-deliver to various congressional offices all letters mailed to the ARRL.

Second, when the ARRL's Washington team delivers letters to a congressional office, it provides them an opportunity for at least a brief face-to-face meeting with some of the key staff members in each congressional office they visit. Each in-person meeting is another opportunity for the ARRL's story to be told – and is another chance to answer questions that may arise.

Dear Representative Marlin Stutzman

For over 30 years the FCC and Congress have repeatedly acknowledged the "strong Federal interest" in effective Amateur Radio communications. The FCC found that municipalities often urrestonably restricted Amateur Radio antennas in residential areas. In its declaratory ruling now codified at 47 C.F.R. §97.15(b) – the FCC determined that:

"Except as otherwise provided herein, a station antenna structure may be erected at heights and dimensions sufficient to accommodate amateur service communications. (State and local regulation of a station antenna structure must not preclude amateur service communications. Rather, it must reasonably accommodate such communications and must constitute the minimum practicable regulation to accomplish the state or local authority's legitimate purpose."

HR 4969 will extend limited reasonable accommodation provisions to include all types of land use regulations, including preclusive homeowner's association regulations and restrictive covenants. The FCC has jurisdiction to provide these protections when there is a conflict with Federal policy. This was established when, at Congress' instructions, it enacted regulations that precepted municipal and private land use regulation over satellite dish antennas and television broadcast receive antennas in residences.

HR 4969 will provide a basis for radio Amateurs to negotiate reasonable accommodatio for at least minimal outdoor Amateur Radio antennas with their homeowners' association. This legislation is critically important to me and to the hundreds of other federally licensed Amateur Radio operators residing in your district. Please sign-on as a co-sponsor of HR 4969.

# AE9YL/7 AND K9LA/7

"AE9YL from K9LA"

"K9LA from AE9YL, go ahead"

"AE9YL from K9LA. You're good and strong, Vicky. We're having lunch now at about 10,200 feet. I can see the mead-

ow with the camp, and boy, is it small."

This QSO took place using our handheld 2-meter rigs during our 7-day pack trip into the Teton Wilderness area in Wyoming. We flew to Jackson on Thursday August 7 and stayed with Wayne N9NG and his wife Margaret. Rich K7ZV joined us Friday morning, flying in from Oregon.

The five of us headed for the trail head early Saturday morning. We were in the saddle and on our way about 8:30 AM. We had three packers (guides) leading us (Stephen, Liam and Stewart), along with the girlfriend (Erin) of the lead packer Stephen. All were in their early to mid twenties, and they obviously enjoyed their work. Having to carry everything in and out of the wilderness, we had a total of twenty eight horses and mules to carry the nine of us and all the equipment and food.



Day 1 – We were in the saddle about 6 hours on the first day (with several breaks in between). After arriving at Camp #1 (along the south fork of the Buffalo River), we had dinner and hit the sleeping bags early. Camp 1 was in a nice big mead-

ow at about 8,000 feet, with lots of grazing acreage for the horses and mules.

Day 2 – We took a day-trip to Angle Lake. On the way back to camp, we took another route. But we had to bushwhack (make our own trail) due to many downed trees blocking the normal path. This trip built up our confidence in the horses in mountainous terrain.

Day 3 – This was a day of rest for both us and the horses and mules due to a strenuous trip the next day to Camp #2. This would have been a great time to play around with a 20 or 17-meter QRP

Day 4 – We were up early (around 6:00 AM) and were packed and ready to go around 8:00 AM (the packers had been up

since 4:00 AM). The ride to Camp #2 took seven hours in the saddle – three and a half hours to lunch at around 10,000 feet, then another three and a half hours to the camp (no breaks except for lunch). Right after lunch we still had to go up to 10,500 feet to cross a ridge, but then it was all downhill. Unfortunately that was the worst case for our

knees (more later). Camp #2 (along the north fork of the Buffalo River) was also in a nice big meadow, but a little bit lower at 7,000 feet.

Day 5 – Wayne, Margaret and I took a 4-hour day trip to the side of a mountain where we could see the meadow with our camp (see the accompanying picture). That's where the 2-meter QSO took place between Vicky and me (she and Rich stayed in the camp with Liam).

Day 6 – We took it easy on the sixth day. We did take a 2-hour day trip to a nice big waterfall along the north fork of the Buffalo River. There was a nice pool at the bottom of the waterfall, but it was just too cold in which to take a dip.



Day 7 – Again we were up early for the trip back to the trail head. It took five hours in the saddle, but at least it wasn't a lot of up and down. We did see a momma and baby black bear on one of the mountain sides. On the way back to the ranch in the van, we stopped to see Bill KE9Z (see the accompanying picture), a former Fort Wayne resident.

We saw lots of great scenery, ate very well (thanks to chef Liam) and slept well (we were very tired after each day). We also enjoyed watching the packers take care of the horses and mules around dinner time, when they were turned loose at night to graze. One horse was always held back and tied to a tree at night in case some of the others roamed too far. Many of the horses and mules also had bells put on them at night to find them easier in the morning if they did roam too far.

Being in the saddle many hours a day took its toll on our knees. Our butts were okay. The constant up and down in the mountains is the problem, with downhill



especially bad. It usually took a couple minutes to be able to stand and walk normally after getting off the horse. We were also fortunate for a somewhat wet summer that allowed us to have a campfire each night (which sure helped for the making of S'mores).

All in all, we enjoyed our trip. If we ever do it again, I will take a QRP HF rig to have some radio fun during the quiet times in camp. Maybe I can even work some DX!

# THE FOX HUNT CHRONICLES

So far, this summer has been a peach, and a welcome reward for that miserable winter we went through to get to it. And so it was on the 3rd of August that four foxhunting teams gathered at the former Marsh Supermarket parking lot in anticipation of a beautiful hunt on a beautiful day. The teams consisted of Jim & Annie Pliett, K9OMA and KA9YYI plus Carole & Al Burke, WB9's RUS & SSE, the team of Charles Ward, KC9MUT & Fred Gengnagel, KC9EZP plus Lori, the team of Linda & Steve Nardin, K9's LAN & SAN, and the team of Bob Dean, KC9UHU & Dave Spence, K9NDU.

Against these eagle eyed (and eared, and generally single conversion implemented hunters), were pitted the wily team of Kim & Jim Machamer, KB9's DOT & DOS who served as the fox for this contest. Jim and Kim were located on and about the West Main St. bridge where is crosses over the St. Mary's river, and from there functioned as the high power fox. A microprocessor controlled 100 milliwatt transmitter served as the low power fox and it was hidden on top of an abutment along the St. Joseph Pathway, and below the railroad bridge that crosses the St. Mary's just north of the West Main St. bridge (i.e., you had to climb a little from the pathway to find the bugger).

The hunt commenced promptly at 13:30 and everyone at the Marsh parking lot starting point heard the high power fox, beckoning us to the south southwest. With everyone lustily singing a line from "A Werewolf in London", off we all went.

We proceeded south down Maplecrest and deduced that the fox was somewhere



near the downtown area based on the DF readings we were getting. I decided to proceed south on Huegenard instead of Clinton in order to avoid the construction on Clinton, and that turned out to be an error because it took us too far west as it turned out, and added to our mileage. Eventually we wound up around Sherman Blvd. and Pape Ave. where we started to hear the low power fox transmissions consistently, so we dismounted and started searching with our hand held gear, Jim listening on the fundamental while I was listening on the fox's third harmonic. Jim, and then I, and then Carole and Annie wandered south on the St. Joseph Pathway along the west bank of the river whereupon Jim found Jim Machamer on the West Main St. bridge. About this time I was using my third harmonic gear just underneath the train bridge and zeroed-in on the low power fox.

As it turned out, the Ward/Gengnagel/ Lisa team found the low power fox first, at fifty five minutes and ten point five miles into the hunt. They were followed by the Dean/Spence team at sixty two minutes and twelve miles, then by our team at sixty five minutes and twelve point three miles, and finally by the Nardin team at fourteen point nine miles and eighty eight minutes.

Based upon mileage and time, the Ward/Gengnagel team was the winner of this one and will serve as the fox for the September competition.

Following the hunt we all travelled over to Coney Island on Main and Harrison streets to partake of their world famous product. They still know how to do it.

#### SIMULATIONS ARE GREAT OPPORTUNITIES FOR EXPERIMENTATION

Every year, members of the American Radio Relay League (ARRL) — the primary national organization of ham radio operators — participate in Simulated Emergency Tests (SET). These events give hams opportunities to practice the skills they'd need in a real emergency, when government agencies and non-governmental organizations might need hams to fill in for non-functioning telephone and Internet systems.

The elected leader of the Indiana section of the ARRL — section manager Joseph Lawrence, K9RFZ — has asked Indiana hams involved in the messagehandling arm of ARRL (the National Traffic System, NTS) to support the League's emergency response arm (the Amateur Radio Emergency Service, ARES) during the SET by transferring messages in a format that's different from that normally used by the NTS. Specifically, Lawrence wants participants to use the Incident Command System General Message Form ICS-213, which is commonly used by the emergency response agencies that ham radio operators would assist during a real emergency.

This form can be downloaded from the ARRL web page and other places on the Internet.

Form ICS-213 is used by incident personnel and dispatchers to record incoming messages that cannot be orally transmitted with accuracy to the intended recipients, according to the outline of one of the Federal Emergency Management Agency's online independent study courses (IS-201, "Forms Used for the Development of the Incident Action Plan"). The ICS-213 is also used by incident command posts and other incident personnel to transmit messages (e.g., resource orders, incident name changes, other ICS coordination issues, etc.) to the incident communications center for transmission via radio or telephone to the addressees. The form is used to send any message or notification to incident personnel who require hardcopy delivery.

Because ARES commonly interfaces directly with agencies whose staff members are trained to use form ICS-213, many ARES members have developed skill at transmitting and receiving via radio the contents of such forms. Generally speaking, members of NTS have significantly less experience in doing so, but considerable experience in a different message form, the ARRL "radiogram."

Lawrence's request that SET participants — including Indiana members of NTS — plan to send and receive messages in the format commonly used by served agencies (Form ICS-213) caused considerable consternation and debate on email discussion groups, particularly a Yahoo group used by Indiana ARES members. Some NTS participants seem to believe that any and all messages that flow through an NTS net — even messages that stay within a section-level net — must be in ARRL radiogram form and that there is no place for form ICS-213 in an NTS net, unless the contents of the form ICS-213 are encapsulated in an ARRL radiogram.

Which leads me (finally) to the point of this article: For the sake of the upcoming SET, **the above concerns don't matter.** 

As its name implies, an SET is a simulation. Like any other simulation, it provides an excellent opportunity to experiment with new techniques, procedures, etc. Some such experiments might fail, but it's

only a simulation, so it's a safe time to fail. After a simulation ends, participants can discuss what happened during the simulation, what worked, what didn't and how operations can improve.

I encourage all Indiana hams, therefore, to participate in the upcoming SET and to use it as an opportunity to experiment with different methods and procedures for handling messages in ICS-213 format.

Try encapsulating one in a radiogram. Try sending one without making it into a radiogram. Try sending them on different modes (including voice and digital).

In short, experiment!

It's only a simulation, so the worst that can happen is that we all learn something.
